

BONUS POLICY

This Bonus Policy of TraderQ operated by Ozifin Tech Pty Ltd (Authorised Rep# 001256645 of AGM Markets Pty Ltd AFSL# 422662) should be read in conjunction with the Account Terms (as may be amended from time to time).

By participating in promotions or accepting any Bonus, you agree to be bound by this Bonus Policy.

General Bonus Account Terms

1. Bonuses and other trading benefits (the "Bonuses") may be offered by Ozifin Tech operating TraderQ (as defined in the Terms of Service) at its discretion.
2. Ozifin Tech operating TraderQ may at its sole discretion restrict who may enter into promotions or receive a Bonus for any reason.
3. A Bonus may only be used once and is not transferable or assignable.
4. Only one Bonus is awarded per person, household, shared computer or shared IP address, unless stated otherwise.
5. You are only entitled to receive a Bonus once (regardless of the number of accounts you have with Ozifin Tech).
6. In order for any and all Bonuses and/or offers to become applicable and accepted by Ozifin Tech operating TraderQ, you must comply with all applicable terms and conditions with regards to the relevant Bonus (for example: as part of one of the conditions to receiving a bonus you may be required to make a minimum deposit).
7. All Bonuses shall be subject these General Terms and Conditions, unless stated otherwise, specific bonuses shall be govern by the "**Bonus Terms**".
8. Bonuses can only be withdrawn when the relevant Bonus Terms have been fully satisfied by Ozifin Tech's satisfaction. If a withdrawal request from your account is made by you prior to you fully satisfying the applicable Bonus Terms (as determined by Ozifin Tech), such Bonus and any profits generated by such bonus will be immediately cancelled and removed from your account.
9. Unless stated otherwise, it shall be a standard term of any and all Bonus Terms that in order to make a withdrawal of a Bonus received by you, you will be required to have a total trading volume of at least 30 times the amount of the applicable Bonus credited to your account (the "Withdrawal Threshold"). The Withdrawal Threshold must be generated within 180 days of the grant of such Bonus for you to be able to withdraw the Bonus. If the aforementioned is not achieved by you, the Bonus and any profits generated by such Bonus will be cancelled and removed from your account.

For the avoidance of any doubt, the above-mentioned calculation method shall comply with the following example: Bonus * 40 = Trading Volume.

10. Once the Withdrawal Threshold has been reached, withdrawals shall be made in accordance with the Withdrawal Policy.
11. Please note, that if you do not log in to your account for a period of 30 days, any active Bonus and any related profits, shall be forfeited by Ozifin Tech without notice to you and are not refundable.
12. If you have a pending withdrawal request, you will not be eligible to claim and/or receive any Bonus.
13. Ozifin Tech reserves the right, at its sole discretion and at a time of its choosing, to withdraw, extend, revoke or amend any Bonuses and promotional offers, or any parts thereof.
14. In the event that you receive a Bonus and the Withdrawal Threshold has not been met by you, as a sign of good faith, you shall be able to request an “Irregular Withdrawal”, which shall be comprised of the available funds in your account (excluding any Bonuses and any profits generated by such Bonuses) minus any losses incurred by you with Ozifin Tech. In no case shall Ozifin Tech be obligated to accept such request.
15. Ozifin Tech takes no responsibility for any inability to enter, complete, continue or conclude the Bonus due to equipment or technical malfunction, busy lines, inadvertent disconnection, Acts of God or otherwise of this sort.
16. Under no circumstance shall Ozifin Tech be liable to you or any third parties whatsoever under any contract, strict liability, negligence or other legal or equitable theory, for any direct, indirect, incidental or consequential damages which you may suffer resulting from the provision of any Bonus.

Ozifin Tech reserves the right to review any records and logs of your transactions and/or account from time to time, for any reason whatsoever. If, upon such a review, it appears that you are participating in strategies or trading activities that Ozifin Tech in its sole discretion deems to be fraudulent, manipulating, involving any cash back arbitrage or in any other manner abusive or deceptive or fraudulent, on or in connection with the provision of any Bonus, Ozifin Tech reserves the right to: (i) invalidate any related transaction, withdrawal, account and/or any profits or losses; (ii) revoke all Bonuses credited to your account and/or any profits generated by such; (iii) restrict or revoke your access to any Bonuses which may be provided at any time in the future; (iv) terminate your access to services provided by Ozifin Tech; and/or (v) terminate your account(s) with Ozifin Tech.
